A letter from the Executive Director & Board President

Connecticut CASA trains volunteers who are appointed by judges to work with children placed under court supervision because of abuse and/or neglect. The mission of our volunteers is to determine the best interests of the child and then advocate for those interests in the courts, with state agencies, in the school system, or wherever else the child's voice needs to be heard.

Five years ago, in March 2020, what is now Connecticut CASA received its first case appointment. From that first case, in the New Haven juvenile court, the program has expanded to seven courts in only four years (with an eighth court added in 2025)! This organization has endured a pandemic, executed a productive merger with local CASA organizations to achieve efficiencies, and leveraged state and national developments to grow and evolve our network. At every inflection point, our focus has remained on the children we serve, who find themselves in what can be a bewildering child welfare system through no fault of their own.

This annual report reflects Connecticut CASA's activities during the 2024 calendar year, with some 96 volunteer Advocates serving 192 children. As part of a national movement for children who have experienced abuse or neglect, Connecticut CASA's volunteers do many things in concert with professionals from social workers and attorneys to educators and health providers. From reporting to judges and connecting children and families to resources, to building relationships that promote youth resilience, our advocates play a vital role.

The Connecticut CASA movement is a community of volunteers and staff, advancing the best interests of children. Thank you to the many volunteers, friends, and partners who made our work possible in 2024! We look forward to doing much more together, for children and families, in the years ahead. We welcome more of you to join us.

- Results that have seen this program grow rapidly, from a single court in New Haven in 2020 to 7 of the state's 10 child protection courts through 2024





Advocacy in Action

CASA volunteers are required to complete our 30-hour pre-service training program and submit to screening and background checks. Volunteers are assigned to only one or two children or sibling groups at a time to allow for high-quality connections and focused attention. Our volunteers stay involved in the case from the time of appointment until the child achieves permanency.



Outcomes of Our Advocacy

How Can a Child in Connecticut Obtain a CASA Volunteer?

Under Connecticut's **2016 CASA statute**, any child with a case involving the Department of Children and Families (DCF) for Child Protection in the Juvenile Court is eligible for a CASA volunteer. Any of the following can make a motion requesting an appointment of a CASA volunteer:

- The Assistant Attorney General (AAG) on behalf of DCF
- The Attorney for the Minor Child (AMC)
- The attorney for the mother or the father could do so

After a motion is made, the judge appoints a CASA volunteer. Any judge in Juvenile Court can also appoint a CASA at any time on the judge's own initiative.

Solutions and support within reach

Darryl*, aged 12 and his 10-year-old twin sisters Sabrina* and Sarah*, live with their mom and two teenage sisters. Their father is prohibited from visiting the home due to past domestic violence. CASA was assigned to Darryl and the twins with focus placed on their school attendance since they were absent most of the previous year.

Mom informed CASA during initial home visits that the children's absenteeism was primarily due to mom's fear that their father might approach them at the morning bus stop or return from school in the PM. CASA assisted mom in enrolling the children in summer school and a new school for the fall, which involved changes in their commute. CASA also advocated for continuing therapy for mom.

Mom's fear of the father engaging the children persisted, with school attendance only marginally improving. Home visit discussions with mom and children revealed that the maternal grandparents were highly engaged with the children, prompting CASA to visit them to explore how they might support improving the children's attendance.

Within its pre-hearing report to the court, CASA included that the grandparents were open to taking custody of the children to ensure regular school attendance, which CASA recommended be pursued. While in court waiting for the case to be called, the grandparents, mom, and attorneys discussed and reached an agreement on the recommendation, which the judge approved in session.

Consistent care, lasting impact

The first time I met Mark*, he was 15 years old and living in a residential treatment facility. He walked into the room, muttered a quick "Hi," then sank into a swivel chair, where he began spinning furiously in an effort to avoid eye contact.

I introduced myself as his court-appointed advocate, someone independent from DCF, whose role was simply to get to know him and be of help when needed. Mark answered my questions with one-word responses, and within five minutes, declared, "There's nothing you can do for me," before standing and dashing from the room.

Fast forward more than two years—we've spent holiday seasons and birthdays together. These days, Mark and I enjoy lengthy, lively conversations. When our time together is nearly up, he often asks if I can stay just a bit longer.


Disappointment and turmoil are no stranger to him. Over the years, he's been moved between three different state facilities and has had multiple DCF caseworkers. But one thing has remained constant: I am still here. I show up when I say I will—always with his favorite snack in hand—and we chat about whatever is top of mind for him.

These days, our conversations often turn to the future. He shares both his hopes and his fears about turning 18. And while the road ahead won't be easy for Mark, he knows he doesn't have to face it alone. He knows, maybe for the first time, that there is something someone can do for him: show up, stand by him, and help him find his way.

Join Our Movement

VOLUNTEER! As a CASA advocate, you become a reliable and consistent resource of support—a constant during turbulent times in a child's life when foster parents, judges, and social workers can change at any given time.

Our volunteers represent a diverse range of cultural, professional, and socio-economic backgrounds, bringing their expertise and compassion to the mission of Connecticut CASA. These are conscientious adults who commit roughly two years to getting to know a child in need of a consistent, caring advocate to listen, learn, and amplify their voice.

As a volunteer you will:

- Receive more than 30 hours of training before being appointed to a case, with 12 hours of continued education required annually
- Receive ongoing support from CASA staff to advocate effectively on a child's behalf
- Visit your child monthly
- Devote 10-15 hours a month of your time
- Stay involved on the case from the time of appointment until the child achieves permanency.
